Background - waste strategy 2030

The Waste Avoidance and Resource Recovery Strategy 2030 (the waste strategy) aims for Western Australia to become a sustainable, low waste, circular economy in which human health and the environment are protected from the impacts of waste. The waste strategy contains objectives to **avoid** waste, **recover** more value and resources from waste, and **protect** the environment by managing waste responsibly.

The waste strategy identifies construction and demolition (C&D) waste as a focus material. The 2030 targets for C&D waste include:

- Avoid reduce C&D waste generation per capita by 30 per cent
- Recover increase C&D material recovery to 80 per cent

Annual Waste Strategy Action Plans identify and prioritise actions across State Government agencies which support the strategy. Headline Strategy 3 - *Implement sustainable government procurement practices that encourage greater use of recycled products and support local market development* – includes commitments which focus on the C&D sector.



C&D Rollout Plan

The Waste Authority's C&D Rollout Plan builds on commitments in the Waste Strategy Action Plans. The C&D Rollout Plan includes priority actions, informed by the Waste Authority's C&D Reference Group, which support the following objectives:

- 1. Develop markets for recycled C&D products
- 2. Support better practice contracting
- 3. Support better practice avoidance and recovery
- 4. Address priority materials
- 5. Reform legislation and regulation
- 6. Improve data.

Roles and responsibilities

The Waste Authority is the custodian of the C&D Rollout Plan. The Waste Authority will support the development of the rollout plan and the delivery of agreed projects. The rollout plan will inform funding priorities in the Waste Authority's annual business plans.

Consistent with the Waste Strategy's recognition that waste management is a shared responsibility, the C&D Rollout Plan will include priority projects led by others, including C&D Reference Group members. Members will also be invited to sit on project working groups as required.

Review

The C&D Rollout Plan will be reviewed annually on advice from the C&D Reference Group.
